#### The Act and its wider legal framework

Bydd Deddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 yn dod i rym ar 6 Ebrill 2016. Mae'r Ddeddf a'i rheoliadau cysylltiedig, codau ymarfer a canllawiau yn arfau gweithredu allweddol wrth wireddu'r dyheadau a gyflwynwyd ym Mhapur Gwyn Llywodraeth Cymru 2011: *Gwasanaethau Cymdeithasol Cynaliadwy: Fframwaith ar gyfer Gweithredu*.

Bydd y digwyddiadau hyn yn galluogi'r rheini fydd yn gweithredu'r Ddeddf yn ymarferol i wneud y canlynol:

- cael trosolwg o'r fframwaith deddfwriaethol llawn;
- cael yr wybodaeth ddiweddaraf am y gyfres o reoliadau a chodau o dan y Ddeddf;
- ystyried eu rôl allweddol a rôl eu tîmau a'u partneriaid cyflenwi i fodloni gofynion y Ddeddf.

The Social Services and Well-being (Wales) Act 2014 will come into force on 6 April 2016. The Act and its associated regulations, codes of practice and guidance are key tools in realising the aspirations put forward in the Welsh Government's 2011 White Paper: *Sustainable Social Services: A Framework for Action*.

These events will enable those who will be delivering the Act in practice to:

- gain an overview of the full legislative framework;
- be updated on the full suite of regulations and codes under the Act;
- consider their key role, and that of their teams and delivery partners, meeting the requirements of the Act.
